Thank you for voting me in as your Commodore. I am honored. I hope I can continue on with the excellent steady hand that our past Com-

The two major topics this month concerning the club are 1) the operating budget, and 2) dredging preparations.

Regarding the first item, you should have received the final 2023 Operating budget in your email. We will be voting upon that at the February General Membership meeting. I wish to thank all the input received by members of the eboard, and especially Kevin Hand and Ken Beghini for taking the time to thoroughly review and prepare the initial budget with me. I feel the Operating budget is now properly ship-shape and ready for your vote.

The second item, dredging, is one that weighs heavily on everyone's mind. Unfortunately, the DEC has the club over a barrel, so to speak, regarding the number of required soil samples and their associated cost. It is much more than expected. I personally believe we have no choice but to pay the money. I also believe, based on their past actions, that the price could actually increase if we wait. As a result, the e-board and I agreed that an emergency proposal is needed to secure the funds quicker than the normal two-vote process. You should have seen this emergency proposal for in both your email and this Porthole. Like the budget, I am hopeful it will pass this coming meeting.

It's our responsibility to complete the sewage & electrical connection from the club house to the new pump(s), run the electric connection from the pump(s) to a new failure warning light/horn, perform a final pump-out of the holding tank and fill it with sand. In the next month we'll be soliciting costs quotes from contractors to perform the work we're responsible for. Will pass on dates as we learn them. It's an exciting time for all-things toilets!

The hors d'oeuvres and cash bar start at 6PM, the buffet dinner will be served at 7PM and the membership meeting begins at 8PM. Spouses and guests are invited. The 2023 dinner cost is \$18 per person.

If you are on the Permanent List but are not able to attend, then you are expected to email Dave to cancel your dinner. All reservation additions & deletions MUST BE MADE by midnight the Sunday before the dinner meeting. Our restaurant host needs a reasonable lead time to estimate food quantity. If you make a reservation and do not attend, then you will be expected to pay for the "no show dinner."

### Social Committee Report #2 of 2:

My first personal goal as social committee chair is to determine how to predict an accurate number of meals to prepare for each dinner event. Jude has helped me out.

Jude Eicas has, until this month, volunteered to schedule the BYC dinner reservations. He has data for the past seven years, 2016 - 2023. Jude is meticulous with his data records and shared with me his spreadsheets of member dinner reservations. I plotted the number of member reservations by month. The individual data points are plotted with the 95% confidence intervals on the mean statistical bars.

There are some caveats to interpreting this data.

This data is collected before, during and after the COVID pandemic. I deleted all the "zero" attendance months. We met via ZOOMTM and there was no dinner. Deleting missing data can be misleading, but not for those dark times. There was also a hesitancy for members to attend dinner meetings leading up to and following the NYS & Monroe County Board of Health restriction on meetings. I included these "hesitant" reservation months.

This data is dinner reservations, not actual dinner attendance. The actual attendance is modified by subtracting the "member no -shows" and adding the "members that showed without a reservation." These adjustments are chaotic and were not recorded.

This data is not meeting attendance. Some members attend the meeting, but do not participate in the preceding dinner social gathering.

This data set is missing a few special events, like our August Pig Roast and the October Corn Beef & Cabbage dinner.

So, what to make of this?

First, Jude is amazing. Thank you Jude for sharing your meticulous records.

Second, the winter months of January, February and March have the lowest average reservations. It surprised me that there is no statistical difference ( $\alpha$ =0.05, 95% confidence) with the months of April, May and August. These low monthly average numbers can be explained. We are not meeting at the desirable club and many members move to warmer climates for the winter months. months, held at the club and catered by Colbys, have a higher average than the winter months held at Fosters. No surprise there.

Fourth, the most important to me, is the large range for the 95% confidence intervals on the mean during the summer months. The number of reservations can have a high to low range of twenty members. This data heightens my concern for a social committee financial shortfall or a shortfall of dinners for members.

Jack Evans & Jeff Spring, Social Chair emeritus, did an amazing task of selling "no show reservations" to the members that "show up without reservations." This is very difficult, not always successful and can be an unnecessary stress on the social committee.

My takeaway from this graph is to emphasize the need for members to commit to reservations. Please be responsible toward timely reservations for social committee dinners. Please commit to a reservation with a sufficient lead time to inform the caterers.

I welcome any conversation on this data, analysis, social committee, or my sailboat. Especially my sailboat, or your boating experiences. I look forward to meeting each of you at this years social dinners or membership meetings.



### Soil samples Long Term Capital Proposal - Emergency Amendment

As previously discussed at the January 2023 meeting, the number and cost of the soil samples required prior to dredging the basin has significantly increased. A quote of \$9711 is attached, which is \$7274 more (i.e., \$9711 - \$2437 = \$7274) than what was approved by the membership last fall. A majority of the eboard agreed that an emergency exists regarding the need for additional funding for the soil samples. As a result, the following emergency proposal is presented to you to fund this effort:

Emergency Proposal: Take additional dollars as required (i.e., currently \$7274) from the Long Term Capital (LTC) improvement fund to pay for soil samples required for dredging.

Date, time and place of e-board meeting: 2/16/2023, 7pm, Foster's.

Reason for Emergency: In order to secure/lock the price of the soil samples, funding is required as soon as possible. A delay for a second vote may increase the price of the soil samples further.

This emergency proposal will also be placed into the Porthole.

Note: This Emergency Proposal is in accordance with the by-Laws section 5d, and will be considered and voted upon at the next general membership meeting on February 23, 2023.

### Long Term Capital Projects Report, Basin and Dredging Testing Requirements:

As you may have already heard, the DEC has rejected our original testing plan which was to combine three soil samples into a single composite test. They are instead requiring four separate samples to be tested, thus quadrupling our original estimate. If you recall in the October meeting, we authorized the reallocation of \$2500 of unused funds from the 2022 (a combination of unused cleaning fees and initiation fees) to pay for the soil sampling. The quote for the DEC mandated sampling plan is \$9,711. To date we have spent \$63.82 on a Coliwasa which is a fancy word for a big neoprene straw that gets stuck in the mud and has been sitting in my living room since December much to Heather's dismay. At the February meeting, we will be making a motion to authorize an additional \$7,274.82 from long term capital. This will be a separate vote from the budget. Unfortunately, this falls into the category of "it is what it is". Without the testing, we cannot complete the application and there is no dredging project in the basin.

This is the time of year when many members are considering their membership options moving forward. Below is the club policy regarding those moves. If you are choosing to resign your membership, please send an e-mail and let us know as opposed to simply not paying your dues invoice and making us chase you down.

Membership policies:

To remind members who may wish to go from Corporate Member to Senior Member, you must send either an email or hard copy mail to the membership committee requesting a change in status. Senior members may return to corporate membership if desiring to dock a boat at the club, by written request to the Membership Committee for approval.

Senior Membership:

- Corporate Members who have been active members for ten years prior to the time when the sum of their years membership and age total 75, may make application to the Board of Trustees of the Club, to become Senior Members.
- Senior Members may attend all regular and special meeting of the Club and vote on all matters except those pertaining to amendments of the Constitution and By-Laws, financial matters, improvements to Club property, or applications for membership.
- Senior Members may not hold office or avail themselves of Club facilities maintained for the purpose of storing, launching or mooring boats.

Members wishing to resign membership shall do so by sending an email to the Membership Chairman expressing their intentions.

As some of you get your GEICO marine insurance renewal bills this year, you may gasp at the 30% increase in your policy cost. Shop around. I got a much better rate for the same level of insurance from a competitor. If you are going to race your boat, always make sure that racing coverage is included in the policy.



# Brianna's Law: Required Boating Safety Certification

Below are the requirements to operate a boat with a motor (any kind of motor) in New York State. The course is easy to find online and many places offer it for free or cheap online or in person.

You have to be at least 10 years old to operate a motorboat in New York or 14 to operate a personal watercraft, such as a Jet Ski.

Below is a table showing when you must have it. Note that in 2025, the table goes away as everyone must have one. Most insurance companies will give you a discount on your boat insurance if you prove you have had the course. I

Under NYS law, known as Brianna's Law, all motor boat operators:

Born on or after Jan. 1, 1993 will need a boating safety certificate beginning in 2020.

Born on or after Jan. 1, 1988 will need a boating safety certificate beginning in 2022.

Born on or after Jan. 1, 1983 will need a boating safety certificate beginning in 2023.

Born on or after Jan. 1, 1978 will need a boating safety certificate beginning in 2024.

All motor boat operators regardless of age will need a boating safety certificate beginning in 2025.

You can have this license added to your NYS Driver's License when you renew.

# BoatUS: New U.S. Coast Guard Fire Extinguisher Regulation Effective April 2022

ANNAPOLIS, Md., Feb. 15, 2022 – A rite of passage for every boater is the annual spring commissioning. Newly added to the boat owners to-do list this spring will be to check all disposable (non-rechargeable) fire extinguisher dates of manufacture, as well as the label for their U.S. Coast Guard classification.

That's because a new U.S. Coast Guard regulation beginning April 20 for disposable fire extinguishers mandates a 12year expiration date from the date of manufacture. Boaters can find the manufacture date stamped into the bottom of the bottle or near the UL label. This may be two or four digits — if it is two, as in 08, that means 2008. Additionally, while the new regulation does not change the type (U.S. Coast Guard-rated) or quantity or requirement for USCG approved fire extinguishers aboard, it does specify the minimum Underwriter Laboratory (UL) classification of extinguishers to be carried aboard certain vessels — depending on the boat's model year.

This is the result of phasing out older "B-I" and "B-II" labels for newer "5-B" "10-B" and "20-B" extinguisher classifications. The number in this new rating refers to the size in square feet of the potential fire the device is suitable to extinguish and not the exact weight of the dry chemical inside the bottle.

Vessels on the water today that are less than 26 feet and model year 2017 or older may continue to carry older, dated or undated "B-I" or "B-II" disposable extinguishers. However, when they are no longer serviceable or have reached 12 years of age since manufacture, they must be replaced with newer class "5-B" or greater extinguishers. Boats less than 26 feet and 2018 model year or newer must carry unexpired "5-B" "10-B" or "20-B" fire extinguishers. Having older "B-I" and "B-II" types do not meet the new carriage requirements.

Many retailers today offer "10-B" class fire extinguishers, which may be a good choice as they exceed U.S. Coast Guard minimum carriage requirements for boats under 26 feet, while at the same time giving boaters more extinguishing coverage. For boats 26 feet or greater, however, having one "10-B" aboard does not equal two 5-Bs. Only a "20-B" classification meets the requirement to carry two "5-B" extinguishers. For a look at how many and what type of fire extinguishers are needed aboard all recreational boats up to 65 feet, go to BoatUS.org/Fire-Extinguishers.

BoatUS strongly recommends going beyond the regulation's minimum requirements. The results from a Foundationsponsored boat burn showed that one extinguisher may give very little time to make an emergency call or potentially prepare to abandon your vessel.

BoatUS also notes that most U.S. Coast Guard disposables on the market today carry at least a dual B:C rating, able to douse both liquids and electrical fires, and some boat owners wisely prefer triple rated A:B:C extinguishers, adding a third protection for combustible fires.

To be serviceable, a portable extinguisher must have a pressure gauge indicating an operable range, lock pin firmly installed, clean discharge nozzle, and no significant corrosion or damage. Some more recently manufactured portable fire extinguishers aboard boats today may carry both old and new labeling, for example, having simultaneous "B-I" and "5-B" classifications.

There are no changes to rechargeable or fixed-mount (i.e., engine room) extinguisher regulations. They continue to require regular maintenance and servicing, typically done annually by a technician.


"This new U.S. Coast Guard expiration date regulation aligns with the 12-years recommended by the National Fire Protection Association," said BoatUS Foundation Assistant Director of Boating Safety Ted Sensenbrenner. "We expect that the U.S. Coast Guard Auxiliary and United States Power Squadrons vessel safety check program will soon include this new regulation as part of their free, no-penalty vessel exams. Because this change affects a critical piece of safety equipment aboard your boat, we also expect the U.S. Coast Guard will initially focus on education. You may want to start checking extinguishers now while your boat may be ashore this winter."


Sensenbrenner adds, "Also take a look now to ensure your fire extinguishers are readily accessible. You can buy only the bracket if you don't have one and mount your extinguishers where they need to be — at points of egress, at the helm, and near the engine and fuel supply. Burying them in the bottom of a compartment ensures they will be hard to reach when you need them the most. Familiarizing yourself with the PASS method (Pull, Aim, Squeeze, and Sweep) will prepare you for fighting a small fire aboard."


