#### VICE COMMODORE



Hi, it's me again! As vicecommodore I am pleased to announce that, after reviewing over a dozen boats, traveling all over the state, losing one truck tire

and evaluating boats in the water on lakes, rivers and down at the club, we have a new committee boat. She will be christened the "Emily Lee" in honor of former member and club matriarch Emily Grape, whose generous donation to the club made this purchase possible. Also, thanks to Bob Spencer, John Saucke, Bill Topping and Mrs. Wiest for accompanying me all over the state to look at and evaluate boats.

The boat we have purchased is a 2008 Angler that is over 20 feet long and is 8 feet wide on the beam with a 1'-6" draft. She is slightly bigger than our current committee boat (I know, I measured:) and has a 150 horsepower Mercruiser twostroke engine with only 330 hours on it. I know this because the previous owner gave us all of the maintenance records on this boat and engine dating back to its original purchase. The boat was shrinkwrapped every year and stored indoors. The engine was also winterized every year. She has lots of storage (even room for a head) and a hull with high freeboard and a bow shape that reduces spray when riding in it. The hull also has no wood in it and is guaranteed for life against rot. Unfortunately the company that made this claim went out of business. But the hull and deck are still in great shape.

Because the owner did not want to pay

another year's worth of storage and winterization costs, we got this boat for a VERY good price. With the money we saved in the purchase, the plan is to put BYC decals on the side (along with the name "Emily Lee") buy a new updated marine radio with a more powerful antenna and install a Garmin chart-plotting GPS that will assist the race committee in laying out and monitoring future race courses.

We will have a short commissioning ceremony for the Emily Lee at our Memorial Day Party in 2024. Past commodore Eric Grape and his family will be invited to it. We will then have a very short familiarization course on how to use this boat for all club members that want to use it. When Bob Spencer and I went out on Irondequoit Bay with the former owner to evaluate this boat, we were very pleased at how quickly the boat got up on plane and how steady the ride was. Club members' concerns (I'm talking about YOU Ted Halsey and Kevin Reitter:) about boat length were heeded. We can't exactly have wild parties on this boat (that's what Ed Vorbach's and John Saucke's boats are for:) and distribution of weight will still need to be observed, But this boat has ridden the best out of all the ones we tested in this price and size range. On a personal note, what pleased me even more than this boat's ride was the simplicity of operation on this boat. The controls on this boat are very simple and intuitive. They are laid out well, which will be key if the Emily Lee is ever needed for a rescue by club members unfamiliar with power boat operations.

To hedge our bets, Kevin Hand has volunteered to put together protocol lists for members to refer to when taking out the boat and operating it on the creek and lake. They will be kept on the boat. Kevin and several others will also be briefing members on how to use the Emily Lee at the Memorial Day party/Christening ceremony. It will be a short familiarization talk. No need to panic; no written tests will be given. I remember how stressed out current member Lynn Keenan got when he stayed up all night studying for his urine test.:0 The plan is to keep the Emily Lee primarily as a race committee boat and to continue using the George Dunn for a lot of the drudgery (ex. picking up channel markers, raking the basin, etc.) that have taken a toll on boats in our club over the years. With the money we saved on the Emily Lee, we will try to make some improvements on the George Dunn, This new committee boat will be a

MUCH more capable race boat. But we can still make the old boat work for certain jobs. We have the room and the means to use both boats to make them last longer and increase capabilities. The new boat is currently berthed in Jack Evans' slip across from the old committee boat. Come down to the club anc check it out..:)

Finally, with a new committee boat dedicated to racing, we need members dedicated to running the races and maintaining these boats. Bill Topping has done a great job for our club over the years. But he has become a victim of his own success and is now in wide demand around the lake. We need to have more volunteers to help run races next year in case Bill isn't available. Rob and Beth Waugh have really stepped up to the plate to help out as has Rob Schaeffer. Thanks to all of them. But we still need more members to help out to make the race run more smoothly in the absence of these hardy souls. I think this is so important that I will be volunteering myself to help out next year on race nights. I hope you will consider to do the same.

Quirks concerning boat operation in Canada would be helpful. I just finished the safety course required in NYS so I hope that NYS certification will work in Ontario. Porta-potties are not allowed in Ontario waters, so that may complicate things.

Is anyone interested in cruising in company for part of the way? Taking our boat for a week or two to give us a break? Doing some sort of tag-team so both parties only go one way?

My (our) friend and sailing guru Greorge Conaty told me something prophetic, like many things the pope would say. "Ed, most people don't get sailing. The moment you set foot on the boat, you're already there..."

So, when people watch me load up AWOL for yet another cruise, I'm always asked, "where are ya going?" And everyone still doesn't get when I say I dunno. I really don't.

I load up for as many days as I can store the boat. I head out and the boat tells me where we are going. When she has the bone in her teeth and she's settled in and I have a beer in my hand, then, and only then can I look at where I might end up.

Adventure. Can't beat it.



# **Brianna's Law: Required Boating Safety Certification**

Below are the requirements to operate a boat with a motor (any kind of motor) in New York State. The course is easy to find online and many places offer it for free or cheap online or in person.

You have to be at least 10 years old to operate a motorboat in New York or 14 to operate a personal watercraft, such as a Jet Ski.

Below is a table showing when you must have it. Note that in 2025, the table goes away as everyone must have one. Most insurance companies will give you a discount on your boat insurance if you prove you have had the course. I

Under NYS law, known as Brianna's Law, all motor boat operators:

Born on or after Jan. 1, 1993 will need a boating safety certificate beginning in 2020.

Born on or after Jan. 1, 1988 will need a boating safety certificate beginning in 2022.

Born on or after Jan. 1, 1983 will need a boating safety certificate beginning in 2023.

Born on or after Jan. 1, 1978 will need a boating safety certificate beginning in 2024.

All motor boat operators regardless of age will need a boating safety certificate beginning in 2025.

You can have this license added to your NYS Driver's License when you renew.

#### **MEMBERSHIP COMMITTEE**

The other way for our club to attract new members is through recruitment by our existing members. That is YOU folks. You are our best ambassadors for the club. If you know someone who may be looking to join a yacht club, invite them to the club and show them around. Explain to them about our self help / volunteer philosophy. If they have an interest in joining and you feel good about them, offer to sponsor them. We have a good number of members who were recruited into the club through current members. If you have an interested party, help them contact the Membership committee (composed of E-board Trustees) or myself and we will guide them through the prospective member process.

# BoatUS: New U.S. Coast Guard Fire Extinguisher Regulation Effective April 2022

ANNAPOLIS, Md., Feb. 15, 2022 – A rite of passage for every boater is the annual spring commissioning. Newly added to the boat owners to-do list this spring will be to check all disposable (non-rechargeable) fire extinguisher dates of manufacture, as well as the label for their U.S. Coast Guard classification.

That's because a new U.S. Coast Guard regulation beginning April 20 for disposable fire extinguishers mandates a 12year expiration date from the date of manufacture. Boaters can find the manufacture date stamped into the bottom of the bottle or near the UL label. This may be two or four digits — if it is two, as in 08, that means 2008. Additionally, while the new regulation does not change the type (U.S. Coast Guard-rated) or quantity or requirement for USCG approved fire extinguishers aboard, it does specify the minimum Underwriter Laboratory (UL) classification of extinguishers to be carried aboard certain vessels — depending on the boat's model year.

This is the result of phasing out older "B-I" and "B-II" labels for newer "5-B" "10-B" and "20-B" extinguisher classifications. The number in this new rating refers to the size in square feet of the potential fire the device is suitable to extinguish and not the exact weight of the dry chemical inside the bottle.

Vessels on the water today that are less than 26 feet and model year 2017 or older may continue to carry older, dated or undated "B-I" or "B-II" disposable extinguishers. However, when they are no longer serviceable or have reached 12 years of age since manufacture, they must be replaced with newer class "5-B" or greater extinguishers. Boats less than 26 feet and 2018 model year or newer must carry unexpired "5-B" "10-B" or "20-B" fire extinguishers. Having older "B-I" and "B-II" types do not meet the new carriage requirements.

Many retailers today offer "10-B" class fire extinguishers, which may be a good choice as they exceed U.S. Coast Guard minimum carriage requirements for boats under 26 feet, while at the same time giving boaters more extinguishing coverage. For boats 26 feet or greater, however, having one "10-B" aboard does not equal two 5-Bs. Only a "20-B" classification meets the requirement to carry two "5-B" extinguishers. For a look at how many and what type of fire extinguishers are needed aboard all recreational boats up to 65 feet, go to BoatUS.org/Fire-Extinguishers.

BoatUS strongly recommends going beyond the regulation's minimum requirements. The results from a Foundationsponsored boat burn showed that one extinguisher may give very little time to make an emergency call or potentially prepare to abandon your vessel.

BoatUS also notes that most U.S. Coast Guard disposables on the market today carry at least a dual B:C rating, able to douse both liquids and electrical fires, and some boat owners wisely prefer triple rated A:B:C extinguishers, adding a third protection for combustible fires.

To be serviceable, a portable extinguisher must have a pressure gauge indicating an operable range, lock pin firmly installed, clean discharge nozzle, and no significant corrosion or damage. Some more recently manufactured portable fire extinguishers aboard boats today may carry both old and new labeling, for example, having simultaneous "B-I" and "5-B" classifications.

There are no changes to rechargeable or fixed-mount (i.e., engine room) extinguisher regulations. They continue to require regular maintenance and servicing, typically done annually by a technician.

"This new U.S. Coast Guard expiration date regulation aligns with the 12-years recommended by the National Fire Protection Association," said BoatUS Foundation Assistant Director of Boating Safety Ted Sensenbrenner. "We expect that the U.S. Coast Guard Auxiliary and United States Power Squadrons vessel safety check program will soon include this new regulation as part of their free, no-penalty vessel exams. Because this change affects a critical piece of safety equipment aboard your boat, we also expect the U.S. Coast Guard will initially focus on education. You may want to start checking extinguishers now while your boat may be ashore this winter."

Sensenbrenner adds, "Also take a look now to ensure your fire extinguishers are readily accessible. You can buy only the bracket if you don't have one and mount your extinguishers where they need to be — at points of egress, at the helm, and near the engine and fuel supply. Burying them in the bottom of a compartment ensures they will be hard to reach when you need them the most. Familiarizing yourself with the PASS method (Pull, Aim, Squeeze, and Sweep) will prepare you for fighting a small fire aboard."
